Upon receipt of the properly formatted spreadsheet, the Claims Administrator will mail the Notice and Proof of Claim form to the names/addresses provided.

Instructions

Please supply the data in Excel format on a CD or floppy diskette using the electronic file layout described below. You must mail your completed spreadsheet to the Claims Administrator within 7 (seven) days of receiving the Nominee Election Letter to the address below:

the field length. If information is pasted into a column, no warning message will appear, but the cell color will change to yellow to alert you that field length has been exceeded.

IMPORTANT NOTE:

Each row of the spreadsheet should include mailing information for a single potential claimant and account. If the listed beneficial owner has more than one account, you must provide the personal information separately for each account. For example, you cannot combine both individual and joint account information under the same account number. In this situation, you should enter all information regarding the individual account first; then, on a separate line, enter the information regarding the joint account.
